- Super Elite:** Elite division winners from the past 2 years and any past Club Championship winner.
- Elite:** Previously placed in the Club Racer division or the former A division.
- Club Racer:** Previously placed in the Novice/New Racer division, the former B or C divisions, or are a ski instructor, instructor apprentice, or patroller.
- Novice/New Racer:** Have never raced before, or have never placed in any division.
- Masters Elite:** Age 50 to 64 who actively race, previously placed in the top three of the Masters division, or previously raced in the Elite or Super Elite division.
- Masters:** Age 50 to 64.
- Upper Masters:** Age 65 and over.
- Snowboard:** Age 18 and over.
- Junior Ski:** Age 17 and under.
- Junior Snowboard:** Age 17 and under.

Liability Release:

I understand that ski racing, training, and related activities are especially hazardous activities and greatly increase the risks of skiing. Race courses may be icy, rutted and/or bumpy and I may be travelling at high speed. I agree to visually inspect the course and the adjacent area before using the course. By my use of the course, I assume all risks, including the conditions of the course and the adjacent area and including the risks of falling or colliding with persons or objects and, particularly, I assume all risks of any personal injury, death, or other damages. In consideration of the Flying Dutchmen Ski Club, Inc., Bear Creek Mountain Resort & Conference Center, Inc., their members or agents and any other person connected with this competition making the opportunity to participate in ski racing available to me, I contractually agree that I freely and voluntarily accept and assume all risks of personal injury or death and fully release and agree to indemnify the above-mentioned entities from any and all liability arising from my participation or presence, including any caused by the negligence of anyone, and accept myself the full responsibility for any and all such damages, injury or death and agree I will make no claims against them.

The undersigned parent/guardian also contractually agrees, in exchange for making this opportunity available to my child(ren), to fully release, defend, indemnify and hold harmless the above-named entities from all claims for damages against it by me, or any minor for whom I have signed, even after they have reached maturity, or from any third party arising out of the conduct of the minor, while participating or present at the racing competition.

I am aware that this contract is legally binding and that by signing below I am releasing my legal rights, as well as those of any minor for whom I am signing.
